

# Tobacco-Free Finance Pledge Signatories show commitment to sustainable finance, hence improving environmental and global health oucomes

### Nest Sammelstiftung and Stiftung Abendrot are two of the first pension funds in Switzerland to commit to The Tobacco-Free Finance Pledge, making the announcement at a roundtable hosted by Tobacco Free Portfolios and the Swiss Lung Association

Nest Sammelstiftung and Stiftung Abendrot have publicly demonstrated their commitment to sustainable finance by becoming Signatories of the Tobacco-Free Finance Pledge.

The Tobacco-Free Finance Pledge is an initiative launched in 2018 during the United Nations General Assembly in New York, to encourage the finance sector to consider the negative environmental, financial and social impact of tobacco companies. The Pledge now has 152 Signatories representing Assets under Management over US\$ 11.0 trillion from more than 20 countries.

As the world learns to manage COVID-19 and the impact of health on global economies it is increasingly important that investment portfolios are aligned with global health goals. In the words of Dr Tedros Ghebreyesus, Director-General World Health Organization, "*It makes no sense to fight tobacco on one hand and finance it on the other.*"

Ceasing the financing of tobacco companies — across lending, insurance and investment — is essential to achieving the UN Sustainable Development Goals. The finance sector can, and increasingly is, playing a positive role in addressing global health, environmental and human rights priorities.

With cigarette butts as the #1 singe use non-biodegradable plastic in the ocean, and eight million deaths worldwide each year due to tobacco-related illnesses, global and multi-stakeholder collaboration such as that demonstrated by The Tobacco-Free Finance Pledge is needed to address the devastating impact of tobacco on society, as well as on the environment.

Nest, the ecological and ethical pension fund in Switzerland, is a pioneer in sustainable investing with a rigorous and independent sustainability approach since its foundation in 1983. Nest has therefore excluded investments in tobacco among other products such as weapons. A logical consequence of this action is signing the Tobacco-Free Finance Pledge.
